1. 1. CALL TO ORDER

- a. Meeting called to order at 6:01 PM

- a. Staff Report Don Craw:
 - i. Tabitha has moved roles and Don will be at AAB meetings when able.
 - ii. Aj Lawson introduced as the new airport supervisor.
 - iii. Craw/Lawson Working on projects that the former REI supervisor had in process.

- b. Chair Forthun- Asked Don when Financials are going to be available for review.
 - Mr. Craw explained financials are submitted at the end of August and will be available publicly in October (unaudited). He will have an update on that next meeting.

 - i. Working on a letter/meeting to a state Rep.

 - ii. SBD safety update
 - 1. Member Pearce, Asked Mr. Craw if the city plans to draft a letter to the FAA on the continued safety concerns of the SBD traffic encroachment. Mr. Craw explained that the AAB can draft a letter and submit it to the city council urging the council to submit the concerns to the FAA on the city's behalf. Mr. Craw continued, the city is choosing to let third party groups like RAA work to mitigate the concerns. Member Pearce strongly opposed the current method the city is using to address the issue and urged that the city take a more active role or the airport could close. Mr. Craw will look into how staff would like to handle this issue.

- b. New Airport Website:
 - Mr.Craw explained the new site is active but not connected to the city link at this time. This should be updated and presentable at the next AAB meeting. Redlandsairport.com

- i. Chair Forthun discussed the possibility of a meeting at the airport to involve the airport community. Mr. Craw noted that any meeting that a quorum is present would constitute a meeting of the AAB. He recommended holding an AAB meeting at the airport if that is allowable from a city standpoint.

Member Pearce asked if the legality was discussed with the city attorney, Mr. Craw will follow up.
