- **G. New Business** Presentation by Mark Cloud, Government Relations Manager, Southern California Edison, "Our Commitment to California: Keeping our communities safe from wildfires"
  - a. The power company for the past 120 years has only supplied power. But with all that has gone on in recent time, the company is now getting involved in various different aspects, such as presentations of wildfires.
  - b. The company is making sure that all the systems are kept safe and reliable for the public.
  - c. California's wildfire problem is serious and worsening.
    - i. Ten of the most destructive wildfires have happened since 2015
    - ii. About a quarter of our service area is located in high fire risk areas.
  - d. Inspections
    - i. In less than five months: crews completed detailed ground-based inspections of 400,000-plus distribution and transmission structures in high fire risk areas.

ii. Deploying helicopters and drones equipped with infrared, ultraviolet, LiDAR and HD image scanning to perform aerial inspections of our facilities in high fire risk areas.

## e. High-Tech Cameras

- i. High-tech cameras help monitor potential wildfires in real time
- ii. By 2020, we will install up to 160 cameras, providing 90% coverage of high fire risk areas.

#### f. Weather Stations

- i. Technology that provides real-time weather forecasting in high fire risk areas.
- ii. Installing 850 weather stations by the end of 2020 as part of our wildfire mitigation program.

## g. Covered Conductor

- i. Insulated wires help reduce wildfire risk.
- ii. Installing 600 circuit miles of the insulated wire by 2020.

#### h. Vegetation Management

- i. Hazard tree removal (beyond traditional trim zone).
- ii. 20-plus in-house certified arborists.
- iii. 500-plus vegetation management crews, totaling nearly 1,000 workers.
- iv. 900,000 trees inspected annually; 400,000 trees in high fire risk areas.
- v. 700,000 pruned per year.
- vi. Vegetation removal at poles.
- vii. LiDAR surveying.

## i. Talking With Our Communities

- i. More than 30 community meetings held in high fire risk areas.
- ii. Meetings scheduled with 120 cities, counties and tribal governments.
- iii. Statewide advertising campaign in market educating customers about preparing for power shutoffs.
- iv. Letters communicating potential power shutoffs planned for all customers in service territory.

# j. Public Safety Power Shutoff

- i. De-energizing power lines to prevent ignitions.
- ii. Used during elevated fire conditions.
- iii. Primarily impacts circuits in high fire risk areas.

- 2. 1st Notification PSPS Possible sent to agencies and customers.

#### iv. 1 DAY AHEAD

- 1. 2nd Notification PSPS Possible.
- v. POWER SHUTOFF
  - 1. 3rd Notification Power Shutoff.
- vi. POWER RESTORATION
  - 1. 4th Notification Power Restored After Inspection.
