- a. Robin Bishop presented on the Local Hazard Mitigation Plan and its updates.
  - i. Hazard Mitigation is any sustained action taken to reduce or eliminate long-term risk to life and property from hazard event.
  - ii. It is mandated by the Disaster Mitigation Act 2000 to prepare multi-hazard mitigation plans as a precondition for receiving FEMA mitigation project grants. The Mitigation Act is part of the Stafford Act.
  - iii. It is reviewed and revised every 5 years.
  - iv. In its revisions it needs to have policy changes, education, outreach, capital projects and now to include climate change and Social vulnerability such as Power Safety Power Shutoff
  - v. Minimize operational downtime and accelerate recovery of government and business after disasters is what drives us to have the hazard mitigation plan in place.
  - vi. The Hazard Mitigation Plan is a full community involvement since the community knows what it is important to have in the city they live in.

- vii. Capital improvements, infrastructure protection, open space preservation, and economic resiliency are items that need to be identified in the plan.
- viii. Example of projects that are included in Hazard Mitigation are:
  - 1. Wildfire mitigation
  - 2. Floodwater storage & diversion
  - 3. Non-structural / Structure retrofitting of Existing buildings
